- Contactless smart accessories with built-in integrated circuits are designed for data recording and transmission via NFC (Near Field Communication) technology. Smart accessories are used as electronic business cards (vCard), ID cards, storage and transfer media for applets and various web links, and as an electronic payment means for bank cards.
- The radio frequency data exchange mechanism is based on standards GOST R ISO/IEC 18092-2015, GOST R ISO/IEC 14443-1 2013, GOST R ISO/IEC 14443-2 2014, GOST R ISO/IEC 14443-3 2014, GOST R ISO/IEC 14443-4 2014, GOST R ISO/IEC 7810-2015.

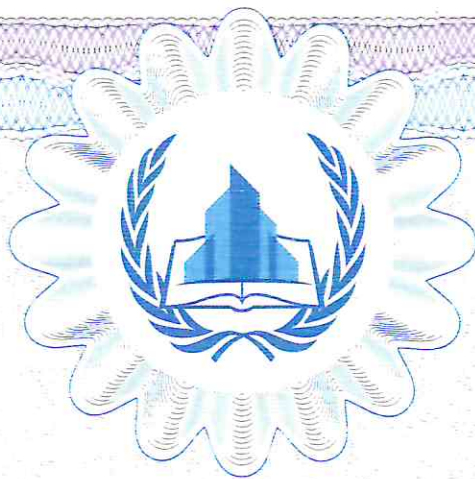

Scope of certification:

- Plastic smart cards made of PVC, ABS, PLA comply with ISO 7810 ID-1 standard: width — 85.6 mm, height — 53.98 mm, thickness — 0.76 mm, corner radius — 3.18 mm. Weight — 7 g.
- Metal smart cards made of steel or brass with a PVC insert and ferrite anti-metal layer: width — 85.6 mm, height — 53.98 mm, thickness — 1.3 mm, corner radius — 3.18 mm. Weight — 25 g.
- Wooden smart cards: width — 85.6 mm, height — 53.98 mm, thickness — 1.55 mm, corner radius — 3.18 mm. Weight — 5 g.
- Smart stickers with epoxy coating, ferrite anti-metal layer, and 3M adhesive layer in round form Ø 30 mm; square form 30x30 mm with corner radius 4 mm; rectangular form 42x26 mm with corner radius 4 mm.
- Smart nameplates made of acrylic. Front size — 110x160 mm, stand — 110x85 mm. Thickness — 4.7 mm.
- Smart casino chip. Poker chips are made of composite plastic with a metal core inside. Chip weight — 11.5 g, Ø 39 mm, thickness — 3.3 mm.
